Analysis of those close in:

TOS- he is the first to come to mind because of the recent issue on the floor. Not only do I hold him directly responsible for the trouble CL was in- thus resulting in the "little" product//... but I also hold him directly responsible for the situation with G and the product of that. Both of which I knew for certain- are the 2 most painful areas of your life. And I also held him responsible for you having the go into the area of 'men'- since he was the first- and he would have pursued it if he hadn't been caught.

And I feel that what he did the other night was amazing to put it mildly... I felt like killing him. He showed absolutely no socialist awareness and was talking very much like a white Conservative capitalist.

I know you have to trust some people- and he has had alot of trust put in him. But he doesn't know himself worth beans- and for that reason alone- I do not trust him. I wanted to bring up the fact that he told me in no uncertain terms that he very much enjoyed that relationship etc. (that night I told you about)- but I don't know how much people can take- and I felt not free to unload all of this on him that night.

I did not see the final conclusion- I doubt that it would matter in my opinion. The damage was done- and in some ass-y cases- I hope it wasn't irreparable.

When you are gone- I don't trust him to rely on women's opinions- I think he has a 'healthy' fear of you and that it must remain that way- since he is indeed very much like a child in many ways. I would hope he would also have a "healthy" fear that if he betrayed this cause- I or someone else would not hesitate to do him in.

I am appalled at his treatment of you and all you have done. I never liked him- and do even less now- I spoke the truth the other night- the only respect I have for him is in terms of the work he does for this cause- but when I see his responses the other night- I ask- why does he do it? What is in it for him? For I don't trust his knowledge of himself at all. And he showed the Socialist mentality at that time -on a very basic issue. I shall continue to watch him carefully- (as I have most of my dealings with him from the start).

Mike P.:

I trust him probably more than TOS- atleast in most areas- but I also feel that he has an 'emotional' lag- of some sort- he doesn't empathize with people or things enough- he is cold- and insensitive many times. And def. lacks tact. I do think he would probably follow a woman's advise quicker than TOS- but I still would question how much he would in a pinch. I also question his tenacity- he hasn't been here that long- and in one PG. he sd. he wouldn't like to be doing this for 5 yrs.

more- I think he relates to you more as a child- and finds a certain 'comfort' in being close to you in the work. I wonder how he could carry on without you. He once said that he was relaxed when you were not around- or out of town- or whatever- because it meant less pressure- or some such thing- which I felt was just the opposite of the way it actually is.

It is much worse for those in authority when you are not around- and I felt that his statement showed at that time atleast- that he was relating as one not left holding the bag- but rather as one who could let up while you were gone.

I basically like him- and feel he has some good qualities- (such as when he was stepping forward to tell the general congregation that he had been fucked etc.) I feel he does have more honesty than the usual (esp. for a 'man')- but I feel he needs the balance of a woman's decision- and also needs to become more realistic in some of his dealings. (and more sensitive)

I basically like him- tho there is a streak of chauvenism that I think runs there- that has to be dealt with- when taking instructions from a woman. That plus the aura of being a "lawyer"- I feel will have to be handled- if you are not around. I don't question his loyalty. But I have my doubts that he would effectively function as a leader 'front'- with directions coming from women- if he had to. He also I feel needs to develop more sensitivity and tact.

But I think I basically trust her- I think she has the principles at heart. I like her- but her paranoid is difficult for me to always deal with- I can't relate to it in such a degree.

Report on conversation with TS secretary:

TS asked me to talk to her about the church etc. and mentioned that JJ wanted us to try to get her in. He (TS sd.) she had been loyal and has helped him with church work (don't know what kind). And that she has always been closed mouth etc.

- ① SB mentioned her own art experience (the secretary is interested in her art work (which in itself is extremely self-oriented) SB sd. her work had not related to the problems around her etc. (no response from Martha)
- ② SB asked what Martha's phil. was- or idea of God- we finally named it as 'Love'- and she felt that not many people felt it or practised it and she felt alienated in that way. I asked her if she thought that people had the ability (used as it was) to express love- or did just a few people like herself know how? She sd. that she thought everybody could feel it if they tried.
- ③ then SB asked what her idea of love was. What it would be like if everybody loved each other.
- ④ then SB equated her idea (Martha's idea) of 'love' with S- and that S was a way of reorientating peoples minds and feelings to a more loving way of living. She thought about this awhile and it finally came out that she was afraid of S because she thought she would have to give up too much of herself and she did not want to do that- she did not want to give up her sleep or her free time or her artwork

she was afraid she would be doing things she did not want to do- I told her I did nothing I did not want to do- I was not made to do anything I did not in actuality want to do. No one force you to do anything under S- you wanted to do it/ She could not relate to this at all- she obviously did not believe there would be that degree of freedom under S-

I do not feel she has a positive opinion of S- and I feel that TS should back off what he had told her about extreme dedication under S and what ever- she has a fear of it- and I believe she is too self-oriented at the moment- she is extremely naive about the world situation doesn't believe about prejudice and the suffering of others that she might help alleviate. She is not ready to actively participate- she made that very clear.

And I question what TS gets in the way of ego boasting from her- she obviously idealizes TS. (SB)

I wish I could tell you how very good it was to see you- to be with you. Obviously, you can tell the difference in me- even tho you say you bring me nothing but pain. How can I convince you that is not true?

I feel like a huge weight has been lifted off me. I am up to my old plateau of depression- instead of the deep valley I was in. I am glad to be back at that functioning level. It had built up for a while- tho I am not sure what started it- probably only things added up. I know that when PJ left- I remember a real hurt then- that just compiled I guess. And when she came back- I knew it was not out of choice- but rather necessity.

Anyway, I feel so very much better- you must see that- and to know that you did it. You can see by what I mentioned of my "programing" from parents etc.- that the only 'love' and understanding that I have known has come from you. My life was always unhappy as I remember- never recall any pleasure- nothing- until you claimed me. How can I let you take any guilt for any of my pain- you caused me none?

This life is pain- whether it is here or there or wherever- but there is no comfort or warmth except where you are. I know how you are about guilt and all- but if I can convince you of just one thing- it would be- that I would not give up one moment that I have had with you- not one lesson that has been sent my way... not one second of fulfillment that you have given me. Quality... is what your love is. And how grateful I am for the time we have together. It has filled this lifetime... many lifetimes- over and over.

And about the operation- I know that I can't convince you of anything there- but I thought about it long and hard... and you had nothing to do with it- whether or not you consented. Obviously, there was that area- that I would have disobeyed- no matter what you had answered- I knew what I was doing. I had seen too much over the past years- where you and little ones are concerned... I would not change my mind- whatever agreement you put up. Obligations or whatever- my feelings are too strong in that area... I will raise other children- fulfill my socialist obligation there- others are more intelligent- younger, strogger etc.- I will help raise there children with whatever ability I have. But I will not raise my own- not knowing what I do about you- can you see that I would have made that choice no matter...?

I am sorry I kept it from you- I would have never told you tho... there are not many areas at all that I would lie to you in- but that was one. But I could see no way out of where you were heading in your questioning. If my desire in that situation counts- then you will not feel badly about what I did. There is nothing you can say- and I mean nothing- that could convince me that what I did was wrong. There could never be the situation exist on this earth- that I would want to put you thru that- selfishly- I would not do it- for my own peace of mind. I am worried about leaving my job position open while our people are still in the community. I feel that while I personally am insignificant- the job is not... on the contrary... it is probably one of the most powerful in the area.

For the following reasons:

- ✓ ① I have DIRECT line of communication with both judges of the Superior Court and to a limited degree with the Justice Court. (I am supposedly the "arm" of the court... ~~is~~ the investigator on their behalf) ... I have a reputation for being "conservative, law & order, strict on the side of the law etc." - and usually the Judges go by my recommendations (as I ask their advice on matters etc.)
- ✓ ② I have DIRECT communication with the law enforcement agencies- Ukiab Police and the Sheriff... ^{Highway Patrol} this enables me to get considerable information... as well as to acru 'favors' in the line of duty...
- ③-I have direct contact with the D.A.'s office , as well as with all attornies in the area.
- ✓ ④ I have contact with the Welfare Dept.- in the various depts. there.
- ✓ ⑤ There is direct contact with all local school administrators and teachers.
- ⑥-I can, thru my job capacity- have considerable access to assorted information throughout the state... as well as other states to a lesser degree.
- ⑦- the Public at large is usually somewhat 'put-off' by Probation Officers- thus enabling me to gather extra information at times and to 'bull doze' thru when I might not be able to if it were a job unrelated to law enforcement etc.

I am not at all opposed to working in the area of co-ordinating the P.L.- I am willing to work in whatever area is best... however, I am hesitant to leave such a "key" position in a small town undefended. (there is absolutely no possiblity of any of our people replacing me- since there is already someone in line for any opening.)

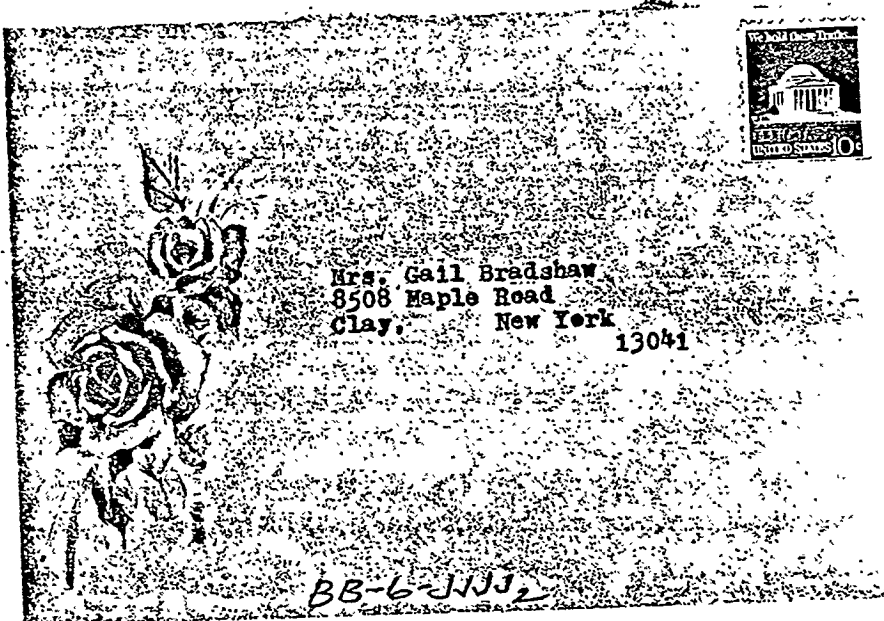

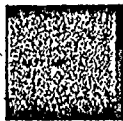

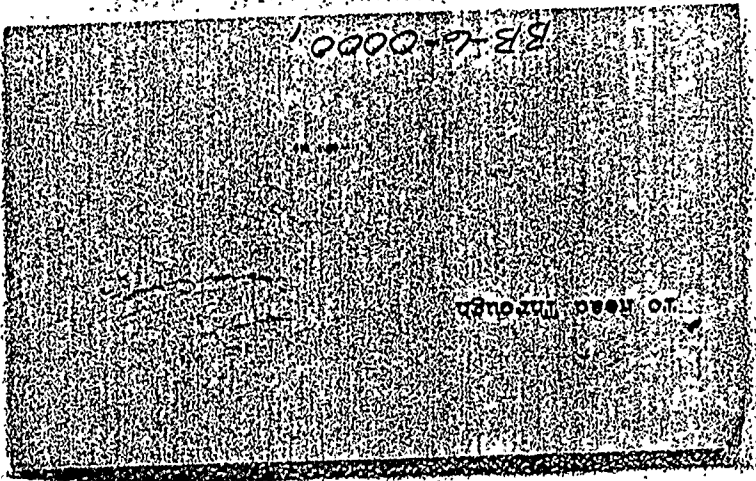

WHAT SOCIALISM MEANS TO ME... AND WHAT I WOULD DO TO SEE IT BROUGHT ABOUT.

Socialism to me- means total equality eventually. Not now, not in the beginning- now it means- some people have to work harder to be examples to others to lure them away from the trappings of capitalism- to the ideals of socialism. To just say to people that under socialism, there will be no more hungry babies, etc.- doesn't seem to make it. Most people don't get grabbed close enough to make them work hard, to give up things to make socialism work.

It is an ideal to work for- not something we have now- or can probably even hope to have so that we- the workers- can reap the glories and benefits of a socialistic way of life. I feel we are, for the most part much too corrupted by capitalism, to become engrossed in socialism as a replacement. Most of us have not suffered enough, or even if we have, there are still remnants of wanting something that someone else has etc, - it looking appealing in some way or other- an intisement (Sp?).

Anyway, I can see that we are going to have a hell of a problem getting most of the people we have now to work and live under socialism. There will always be petty jealousies and comparisons as has been set up by the capitalists. How to get rid of them? When will the big purge come?? When we are all hungry-? or on the way to jail?? Somehow, I don't think so.

Socialism is an ideal... and some of us are idealist in one sense and dreadful realists in another sense. But just because we ourselves cannot be in the new established order that is to come- does not detract from the beauty or righteousness of it.

Socialism + (Communism) is a total re-orientation of our previous way of thinking. A new outlook on not only ourselves as individuals, our work habits, our attitude towards work, our feelings for others, relationships etc. but it is also a complete dying of our present thoughts and ideas, things we have been brought up with- things that seem to be habits, even thought J example has shown us higher ideals- we are still for the most part in a capitalistic groove.

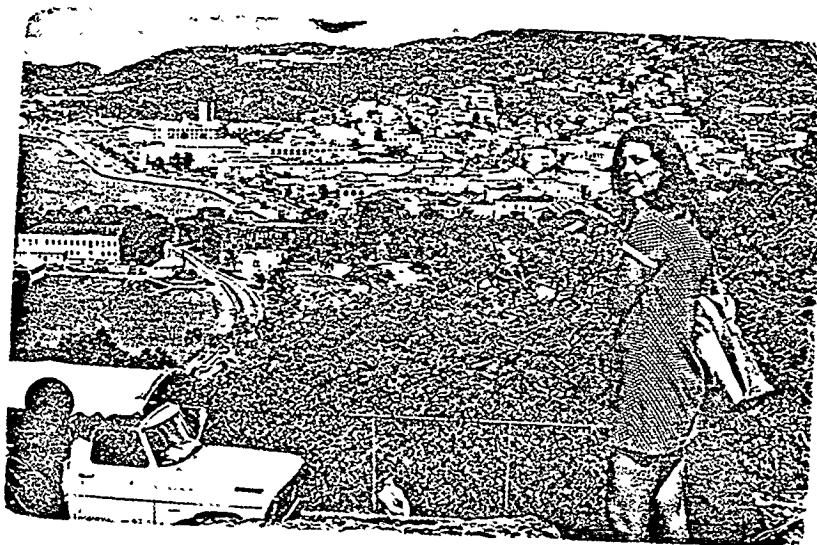

1- there is ^(appears to be) ~~actually~~ very little actual contact and calling being made- there are a small number of people doing calling- (and probably not all very competent representatives)- it seems that Rhonda does few calls- (even with her other jobs- it would seem she could do atleast 'several' a day- but this is not so.

2- on their calling and visitation- they seem to be going over and over the same people. Follow-up should be done- but they are not reaching enough people.

3- I have found few- or no- listings of visitations or calls from either Johnny or Paul- maybe they don't report them to Rhonda and that committee- but neither do they give me a schedule or any accounting for their time (for possible suggestions of improval etc.)

For example- listed the weeks report of July 11,- (not clear exactly what length of time this entails)- Dorothy Brewer made 1 call on 6/29 and 4 calls on 7/2/

on the Suspension calling for the same date (July 11)- there were .7 calls made by Sheila Cole on 7/1
.8 calls made by Gary Tyler on 7/1
4 calls made by Rhonda F. on 7/1
.6 calls made by Helen Cole on 6/29

listed on the same report was the figure of 158 on the Regular Suspension list (members that have missed 4 meetings)

and 189- of Suspension II- those who have missed 12 or more meetings (there should be MUCH more contact with these people) (these have no phone)

and 533 of Suspension III- missed 12 or more meetings- these people have phones- so def. SHOULD be contacted.

I know for a fact- that there are many, many people who have for 1- reason or another stopped coming- (many OT's don't come anymore)- and I think this should be a ~~major~~ major phase of L.A. leadership.

In June of 1972 Jim Cobb ~~approached me~~ ^{said that he thought that} I would make it (meaning a Black militant revolutionary). I knew that was what he meant because the point of all those little catharsis meetings was to bring us all around to this. He emphasized that I was going to be all right and with that he kissed me. I thought that he was so committed at the time but backed out of any kind of an affair because of fear of being brought to council and fear of ~~receiving~~ ^{receiving}. He had a manipulative approach about dedication to the cause. He hates me and called me a racist in July '72 for something as trivial as not ~~wanting~~ ^{wanting} to drink out of a coke bottle that he had. One thing which struck me funny is that I always felt uncomfortable saying what an asshole J.C. was around Mickey. She never talked bad about him and when I did ~~never~~ ^{never} commented.

Re: Terri Pietals

Terri told Diane Wilkenson to pretend that she had a gun and to put it to my head and ~~maybe~~ ^{maybe} then I would talk (~ April '72) — Diane did it.

Terri had a hold over Mickey (not that Mickey didn't want it). She came down to see Mickey ~~for~~ ^{for} a few days before they left and stayed out until early in the morning. Mickey drove down to S.F. several times last year before she started working to see Terri.

Mickey acted real sulky and moody around the dorms after Jim Cobb told her that all of us were going to Redwood Valley ^{to the} (she told ~~me~~ that). She slept a lot and when I asked her what was wrong she acted like it was nothing or my imagination. This was about mid-July and it was within a week before vacation that she started acting what I thought was normal.

Mickey always talked about how ~~the~~ sick male-female sexual relationships and said at least homosexual relationships were more honest. When I confronted her with the fact that all relationships were sick she seemed reluctant but did half-heartedly agree which makes me think that Terri was ~~what~~ her motivating factor. I'm sure she had something going with Jim Cobb also because when I came home from school Jim would leave and go upstairs (I figured it was just because of me → I knew already that he hated me so nothing seemed strange because I thought it was Ava and John that he was hanging around.

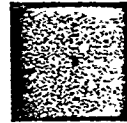
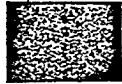

Report on CRL work situation:

Last week she and PJ were in L.A. (the week of Feb. 17-21)// they had 108 things to work on- and 5 full days in which to work as they stayed down there after the L.A. weekend. I got back approx. 40 things... and 21 of them were C's that PJ did. My records show they did nothing the 17th- and 4 V's on the 18th// and PJ did 6 C's on the 19th and PJ did 14 's on the 20th and CRL did 5 V's PJ did 1 C on the 21st and together they did 9 V's

PJ typed the above and said that CRL had the rest of the work... I asked CRL about it and she avoided the issue- and finally said she had 12 of something (C's or V's??) somewhere... when I asked her specifically for them last night- she went to get them (supposedly) and left the house... we didn't know where she was (not at the office) until the next day(??)

I had KL tell her again when they went to leave for S.F. together to leave the stuff as I had to get this weeks work together-.. and nothing was left- so I assume that there is nothing to leave.

She acts this way when she is hiding something (i.e. when she stole the \$50 from me in change- she "went to get it" about 5 times- and obviously had no intention of returning it as it had been spent previously)

I gave she and PJ \$120 for the week and got none back- the last time she and PJ were supposed to go to L.A. (PJ. had to fly back) I gave them \$140 plus \$20 apiece for their own spending \$- and again I got nothing back- (and CRL gave me a flimsy accounting for \$140 of it (counting the 20 apiece)- so I think she got atleast \$40 of that \$ if not more.

She was home all day Mon. and slept most of the day- and did not clean out her "stuff" from Sun.- she left it in the back of her car- (I got it out and disposed of it- and LA. brings the new) This is her only "responsibility" and she won't even do that- she still carried the bottle of "B"

around under the bus even tho we have told her countless times not too- and leaves old "stuff" under the bus for week of so between meetings- and that smells so that other people notice it.

I feel she is extremely careless- I find bits of papers all over- (in her car etc.) and I think she would really like to see this work come down. I do not know how to deal with her particular brand of insanity- she has the intellectual capacity to grasp what we are doing- but it so self oriented that she is an obstacle- and possibly a dangerous traitor.

I feel so hostile to her- that if she ever did anything to hurt this work- I would kill her. I feel that her kind would deserve no mercy- as she knows exactly what she is doing. I don't think she is any more "crazy" than the rest of us.- its just her type of manipulation.

With the small amount of work she does and the hazards she creates- if we were to send her somewhere else- (the jungle????) we would not really miss her "contribution"/

I feel somewhat limited in how much I can personally deal with her because of other things... and I know everybody else is worried to confront her and she insists on acting so crazy and irrational.

I hate to even mention this to you- but I feel she is a very real source of potential treason- and she is not improving (or it doesn't seem to me) Too bad Mike can't fuck her etc. and get it over with- (too bad for mike but)....

I can really offer no suggestions- and the situation can go on as is - (it has been so for years- or atleast 1 yr.) so we can keep on pulling her along- (it does seem that she is increasing careless with her "stuff" tho-) KL sd. she used "fish" the last L.A. weekend- and it smelled distinctly so- and etc. etc. and so on.

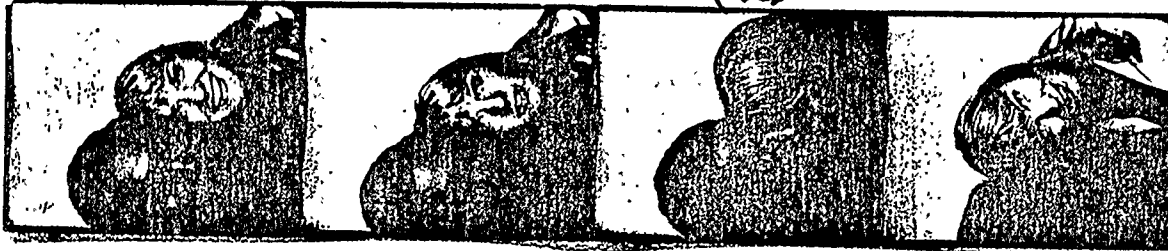
